GREETINGS FROM THE VILLAGE PRESIDENT

This is my favorite season in the Village. The Great Pumpkin Display brought to us by the Whitefish Bay Civic Foundation and the Holiday Stroll sponsored by the Business and Professional Association remind us of the importance of civic engagement and private contributions to the well-being of a community. The local government budget process, while hampered by delays at the State level, proceeds with the professionalism of Village staff with policy direction and review by the Trustees you elect to represent your interests. Fiscal responsibility and meeting the service needs of tax payers are both at play in establishing the annual budget.

The Whitefish Bay Business and Professional Association is also busy working with the Community Development Authority and the Village Board to assure a vibrant business district. Watch for progress as the details of the conceptual plan for streetscaping on Silver Spring are refined. Similarly, a visioning session jointly sponsored by the CDA and the business association brought prominent speakers to discuss development potential in the business district and the opportunity for additional citizen input. The staff and Board continue to explore opportunities to further implement the Master Plan.

Despite concern over some of the vacancies on Silver Spring, several of our businesses are doing better than ever, and there are some exciting opportunities to be explored. Kudos to the many of you who took the time to determine the facts before responding to the rumors about CVS. The fact is that while CVS did look at a site on the southeast corner of Silver Spring Drive and Santa Monica Blvd., the Village has not received an application for a Conditional Use Permit that would be required for further consideration to proceed. Nothing is under consideration at this time. Further, any formal application would require public notice and a public hearing.

Unfortunately, some people were similarly misled when they were told that Village ordinances discourage restaurants on Silver Spring. The myth that a liquor license would not be available for a restaurant is simply not true, nor has the unavailability of a liquor license been a factor in the decision of a restaurant looking for space in Whitefish Bay. I commend those of you who took the time to consult the website or contact our Village Manager to verify the facts in these situations and encourage all of you to consider the importance of sound information in good government decision-making.

Finally, I am pleased to report that the Village has approved the hiring of a second Building Inspector to meet the demands associated with unprecedented levels of additions and remodeling, and an assistant Village engineer to help manage the increasing demand for street maintenance and improvements. These positions should increase efficiency and responsiveness to your needs.

May your holidays be peaceful and prosperous.

REAL ESTATE TAXES

The 2007 Real Estate Tax Bills will be mailed to property owners before Dec. 14. Tax bills are due and payable no later than Jan. 31, 2008. Taxes may be paid in installments with the following schedule:

50% due by Jan. 31
25% due by March 31
25% due by May 31

All special assessments or delinquencies are payable with the first installment of taxes by Jan. 31.

Village Hall is open Monday - Friday from 8 a.m. to 4:30 p.m. If taxes are paid by mail a receipt will be returned to you. Village Hall will be closed on Monday & Tuesday, Dec. 24 and Dec. 25 and on Tuesday, Jan. 1, 2008. Village Hall will be open for tax collections on Monday, Dec. 31 from 8 a.m. to 4:30 p.m.

FROM THE DEPARTMENT OF PUBLIC WORKS

HOLIDAY TREE DISPOSAL

Village crews will **collect Christmas trees placed at the curb from Jan. 4 until Jan. 25, 2008.** They are not collected as part of the regular garbage route. Please remove lights and ornaments as they are a disposal hazard. If it should snow and your tree becomes buried in a snow bank, please dig it out and place it on top of the snow bank to ensure that it will get picked up.

PUBLIC SIDEWALK SNOW SHOVELING & ICE CONTROL

Village Ordinance **requires residents to clear sidewalks of snow and ice within 24 hours after a snow / ice event.** If you live on a corner or an intersection that has a crosswalk, **please shovel the crosswalk out.** If that crosswalk is a handicap accessible ramp, the walk area should be cleared out wide enough to accommodate a wheel chair. Failure to do so may result in a citation of \$103.50 in addition to a cost for removal / de-icing by the Department of Public Works. If you are going to be out of town, please arrange to have your sidewalk kept free of snow and ice.

If you need assistance, you may want to contact the Recreation and Community Education Department at the School District at 963-3947 which sometimes has a list of students interested in snow shoveling jobs.

REFUSE COLLECTION - SNOW REMOVAL & ICE CONTROL ON PRIVATE WALKS & DRIVEWAYS

In order to prevent the collectors from injury, please have access to your refuse receptacles free of snow or ice. This includes walkways or your driveway from the street to the receptacles. In addition, please dig out and pull out the receptacles to make sure they are not frozen in.

SNOW REMOVAL

It is against Village Ordinance to push, pile, blow or shovel snow into and across a public street or alley. If you have a contractor removing snow, please remind him / her of the rules. Snow windrows can cause

damage and injury if left to obstruct roadways. It also creates significant cost over-runs when Village crews have to remove and clear roadways again.

SNOW REMOVAL – FIRE HYDRANT

If you have a fire hydrant in front of your property please shovel it out so that the Fire Department has access to it in case of emergency. The life it saves may be your own.

SNOW & ICE CONTROL POLICY

The Department of Public Works gets several calls a year regarding snow removal and ice control policy on secondary roadways. For environmental reasons, the Village tries to limit use of road salt on secondary streets to only intersections. During snow melt and winter rains, the residue from road salt enters the storm sewers and makes its way out to Lake Michigan. Road salt however, is a necessity and therefore the Village has tried to balance environmental and safety issues by implementing a “low” salt policy.

ICE RINK

The Department of Public Works will try, but cannot promise, to have an ice rink for the winter season. Making and maintaining ice in southeastern Wisconsin with the warming affects of the Lake is very weather-dependent. Typically a long sub-freezing cold spell in December is needed so the ground is frozen solid under a rink, and by March the weather gets too warm to sustain the ice. Klode Park is typically the preferred location because it is easier to get a base ice condition established.



GARBAGE ISSUES

DISPOSAL OF MEDICAL WASTE

Syringes, needles and other medical waste must be disposed of properly. Medical syringes and needles pose a health risk to Village’s collectors as well as all those who handle the solid waste stream. Although the Village takes as many precautions as possible to protect its crews from blood borne pathogens, it is difficult to protect them against such items as syringes and needles. Please ask your pharmacist how to dispose of medical waste properly and see if they provide disposal services. The web site also has a list of disposal facilities in the North Shore area.

DISPOSAL OF REFRIGERATORS, AIR CONDITIONERS AND DEHUMIDIFIERS

The Village is unable to pick-up refrigerators, air conditioners, dehumidifiers and any device that has refrigerant. It is also unlawful to take these devices apart and empty the refrigerant. You must call a company that specializes in these pick-ups. One firm that typically picks up in the Whitefish Bay area is Refrigerant Recovery, (414) 643-7740.

DISPOSAL OF GREASE

Don’t pour that bacon grease down the drain! Grease comes from meat fat, cooking oil, sauces, butter and margarine. Pouring fats, oils and grease down the drain can cost you big money for plumbing repairs and causes sewer overflows. Grease sticks to the sides of sanitary sewer pipes and over time can clog them.

A clogged sewer pipe is not as easy to deal with as pouring drain cleaner down a pipe. Pour grease into a can or blot it up with paper towel and put it in your garbage.

WHAT'S UP WITH COURTLAND PLACE?

Planned pavement work on Courtland Place has been postponed until Spring 2008. The decision to delay full reconstruction was made after the utility contractor did not meet the deadline for that work, which was not completed until Sept. 13. Because of the delay, the earliest the pavement work could have been scheduled was the end of October and it was estimated it would take about three months under good conditions, which usually do not exist this time of year. Therefore a decision was made to postpone paving and apply an emulsion to the roadway for winter.

Reconstruction work should begin about the middle of April with a completion date of July 15.



FROM THE POLICE DEPARTMENT

CRIME PREVENTION REMINDER

When going on vacation, there are steps you can take to improve the safety of your residence. Please consider the following:

- When leaving on vacation, notify a trusted neighbor, relative or friend of your absence and how you can be reached in an emergency.
- Arrange for someone to inspect your property regularly.
- Make sure your home looks lived in.
- Lock all windows and doors.
- Put an automatic timer on several lights.
- Stop mail and cancel all deliveries, or ask a neighbor to make daily collections.
- Have a neighbor keep your property maintained, including snow removal in winter.
- Ask a neighbor to occasionally park in your driveway.
- Vehicles parked outside should be moved occasionally to appear they are being used.
- Have a neighbor place garbage containers at your curb on your normal pickup day, and return them after pickup is made.
- Don't leave your absence on answering machine messages.

PROTECT YOUR PET

Many dogs and cats get loose throughout the Village and in surrounding communities. Most are located and returned to their happy homes, however there are many others that are brought into the Police Station and are placed with the Milwaukee Area Domestic Animal Control Commission (MADACC) in hopes of being recovered by their owners.

Microchipping your pet is one way of positively identifying your pet. The microchip is a small grain of rice sized glass encapsulated computer chip with an identification number and miniature antenna implanted under the skin. MADACC carries a micro chip reader in their vehicle. Each domestic animal they retrieve gets scanned to see if they have the chip. Even if some area shelters routinely check for microchips, please keep a collar or harness with an ID tag on your pet with your current phone number. The first person to find your pet will not have a microchip scanner/reader, but will probably have a cell phone.

SHOW YOUR PET THE LOVE AND CARE IT DESERVES BY FOLLOWING THESE SAFEGUARDS:

- 1) Purchase a yearly license
- 2) Stay current on all vaccines and keep good health records
- 3) Purchase a name tag
- 4) **Keep Collar On.** (collar should display all tags).
- 5) When outdoors, please make sure your pet is secure on your property and kept on leash when walking.

WHAT TO DO IN THE EVENT THAT YOUR PET IS MISSING:

Contact the Police Department (962-3830) with a complete description, and the date, time and area the pet was last seen in. Also, contact MADACC (649-8640) to see if they already have your pet.

ADULT HEALTH RISK SCREENING

(by appointment)

This program includes blood analysis for total cholesterol, HDL, LDL, triglycerides, and glucose; blood pressure and weight check; plus consultation with a registered nurse. Cost is \$25. (Cash or check only)

IMMUNIZATION CLINICS

By appointment. Most childhood immunizations are \$5. Meningococcal is \$15. Pneumonia vaccine costs \$45 (if age appropriate, we will bill Medicare) Tetanus is \$25. Hepatitis B vaccine is available for adults at a cost of \$100 for the series. The fee will be collected when the first dose is administered. TB tests also administered and the cost is \$10. **WE HAVE A NUMBER OF OTHER VACCINES, CALL TO CHECK AVAILABILITY AND COST.**

BLOOD LEAD SCREENING

(by appointment only) (ages 1-5 years)

For the uninsured or those whose insurance does not cover this screening. Cost is \$5.

TESTING FOR LEAD IN WATER:

Collection kits are available at the health department. Kits contain all needed materials and instructions for collection of a water sample. All samples and fees (\$42 per sample) are to be delivered to West Allis Memorial Hospital Toxicology Lab to be sent to the State for analysis. Results will be sent to your home.

HEPA-VAC RENTAL:

The health department has a Hepa-Vac vacuum cleaner available for public rental. The Hepa-Vac is used to clean up after a remodeling project disturbs lead paint. The Hepa-Vac will pick up the fine lead particles unlike a regular home vacuum, which will spread the hazardous particles.

There is a \$25 (refundable deposit) and \$10 per day rental fee.

WISCONSIN WELL-WOMAN PROGRAM

Will provide free health screenings and diagnostic tests for several conditions, including mammograms and pap smears, for women 50 through 64 years of age who meet income guidelines.

LEAD

Recently, there has been a number of recalled products due to high lead content. A list of all recalled products; toys, jewelry, clothing and more can be found at <http://www.cpsc.gov>. The U.S. Consumer Product Safety Commission (CPSC) is charged with protecting the public from unreasonable risks of serious injury or death from more than 15,000 types of consumer products. Information on lead in cosmetics can be found at <http://www.safecosmetics.org>.

According to the Centers for Disease Control and Prevention (CDC), all children should receive a blood lead test at one year of age, two years of age, and at three to five years of age if not previously tested. Blood lead tests should also be performed on children under six years of age before and after undertaking any remodeling/renovations to assure that no exposure occurred during the renovation. Blood lead tests may be obtained through your child's healthcare provider or by scheduling an appointment with the Shorewood/Whitefish Bay Health Department at 847-2710.

HISTORIC PRESERVATION COMMISSION ADDS 6 HOMES TO AHI

Six homes built for one of Whitefish Bay's pioneer families have been added to the Whitefish Bay Architecture and History Inventory by the Historic Preservation Commission.

William Consaul, his second wife, Hannah, and his seven children left New York in the 1800s and were among the earliest residents of the farming community that became Whitefish Bay.

In 1853, William acquired 30 acres bounded by Lake Michigan and present day Santa Monica Blvd., Silver Spring Dr., and Lake View Ave. The original Consaul home is believed to be **716 E. Silver Spring Dr.**, bordering east of Johnson Bank, and may be the oldest surviving residence in Whitefish Bay.



William left the house to a son, William Henry, when he died in 1855. William Henry and his wife, Ruth, lived in the house until conveying it to their daughter, Mary Jane, and her husband, Lewis Schiefe, after they married in 1884. In 1894 the house became the Kilbourn Fresh Air Society Home for Children before returning to residential use.

In 1864, William Henry and his brother, Theodore, began commercial fishing in the bay. The business was later sold to Schiefe who supplied the Pabst Whitefish Bay Resort and other establishments with whitefish. It is likely the village's name originated from their fishing enterprise.



William Henry and Ruth moved to a new house now at **5654 N. Santa Monica Blvd.** William Henry died in 1889 and Ruth turned over the home to a daughter, Emma, and her husband, Gustavus Luecke, in 1891. The Lueckes in 1920 passed on the house to Mary Jane and Lewis Schiefe.

When William Henry built his new home, he also built a bunkhouse for farmhands at what is now **5668 N. Santa Monica Blvd.** It was later converted to a single-family home, and at one time featured a front porch.



Two sons of William Henry and Ruth built homes nearby. William Thomas (Patricia) Consaul built the house at **5682 N. Santa Monica Blvd.** in the mid 1880's.

His younger brother, Frank Webster (Louise) Consaul, built the house at **5700 N. Santa Monica Blvd.** in 1893.



The four Santa Monica Blvd. homes were influenced by Victorian Gothic architecture, a style popular in Milwaukee during the 1870's and 1880's and used on cottages to mansions.



Two daughters of William Henry and Ruth, Susannah (Henry) Marsh and Ida (Michael) Carney, owned homes where Fitzgerald Pharmacy and the Fox Bay Theater now stand. In 1921, Susannah's daughter, Ruth (Gordon) Nelson, built a home at **5685 N. Consaul Pl.** on former Consaul farmland. Ruth was the great-granddaughter of William, the original Consaul family settler.

William, William Henry, Mary Jane, Frank Webster, Susannah, and other Consaul family members and spouses are buried in the Town of Milwaukee Cemetery in the 5900 block of N. Lydell Ave. north of Bayshore Mall.

The inventory is a registry of historic and architecturally significant homes in Whitefish Bay. It currently lists nearly 80 homes.
