FROM THE VILLAGE PRESIDENT

Welcome to December. It is hard to believe that another year has sped by. It has been a busy, productive year for the village. Some highlights include the passing of the 2014 budget, the groundbreaking of two large projects including the new DPW building and the Beaumont Place Apartments, the completion of the new baseball diamond and the retention area at Cahill Park, multiple new businesses on Silver Spring and more.

The 2014 budget for the village includes a small increase in the tax levy. We were able to keep taxes stable due to the hard work of staff. With increased financial restrictions put on municipalities by the state, increasing costs in general and decreasing revenues, the village has adopted a budget that continues to serve the community and allows for a continuation of needed capital projects with no cuts in the high level of services that all residents receive. The budget is disciplined, following closely the recommended CIP that the board adopted in 2012, with some flexibility as needed. It continues to fund projects to address the EAB issue and continues with street, sewer and storm water improvements and much more. The 2014 budget is fiscally responsible and still allows for the amenities that make WFB so attractive.

The DPW building is nearing completion and should be ready for occupancy in January. This is a project that began earlier in the year and will allow for WFB to own its own facility. This project began with an idea that, while it would be great to own and operate our own facility, it needed to be done without an increase in the tax burden. This was accomplished and the overall debt burden will be less than the expected rent, utility and property tax payments that the village is currently paying. The engineering staff will have their offices in the new building.

The Cahill Park Stormwater Retention Facility and new baseball facility are mostly completed. This facility will be instrumental in helping to retain and manage stormwater and was financed in part by a \$4 million grant from FEMA, which realized both the need and the benefit of this project. Working together with private groups and the school district, the state of the art baseball complex is going to be well used starting this spring.

The other large capital project that village completed this year was the overhaul and re-painting of the water tower. This project included the removal of the existing cell towers, sandblasting of both the inside and outside of the tower and four coats of new paint. This project added 50 years of new life to the tower.

Silver Spring continues to offer an environment that is attractive to both shoppers and new businesses. This year, we have welcomed The Bay Restaurant, Roman Candle Pizza, G&S Cupcakes, Vinamo Restaurant (opening soon), 9 Round Personal Fitness, and Erik's Bike Shop. This is a shopping district owned, managed and run by people who value working within the village. During this holiday shopping season, please support all of the merchants by eating, shopping and recommending them to your friends.

As always, have a happy and safe holiday season.

**SNOW AND ICE REMOVAL REGULATIONS:**

Winter is upon us and that means it's the time of year to be aware of the responsibilities property owners have when sidewalks become covered by snow and ice. According to Village Ordinance 7.08(1): The owner, occupant or person in charge of each and every residence or building in the Village of Whitefish Bay fronting upon or adjoining any streets, and the owner or person in charge of any unoccupied residence, building or lot fronting or adjoining any street, shall clear the sidewalk in front of or adjoining such residence, building or unoccupied lot, as the case may be, of snow and ice to the width sufficient to allow adequate passage for pedestrians passing each other in opposite directions within 24 hours after snow has ceased to fall, and cause the same to be kept clear of snow and ice. However, when ice has so formed on any sidewalk that it cannot be removed, then the person herein referred to shall keep the same sprinkled with sand or other substance to provide traction and shall remove the ice as soon as removal is possible.

A second ordinance to be aware of pertains to machine noise caused during snow removal. Village Ordinance section 8.02(5)(a),(b) and (c) state: within fifty (50) feet of any building used wholly or partially for residence purposes, machine noise is prohibited between 10:00 p.m. and 6:00 a.m. Except as otherwise permitted herein, snow plowing by means of vehicle driven snow removal equipment utilizing a back-up alarm is prohibited in the Village between 10:00 p.m. and 6:00 a.m. Snow plowing by means of vehicle driven snow removal equipment legally without the use of a backup alarm shall not be subject to any time restrictions.

STORMWATER UTILITY INFORMATION

HOW IS STORMWATER REGULATED?

The foundation of today's stormwater regulations lies in the Federal Water Pollution Control Act, commonly known today as the Clean Water Act due to its focus on cleaning up our rivers, lakes and streams. In Wisconsin, the Department of Natural Resources (WDNR) is responsible for carrying out this federally mandated program. This is accomplished through a series of state rules developed by the WDNR that regulate construction sites, industries, and municipalities. These rules are changing how the Village of Whitefish Bay conducts its stormwater management program.

HOW DO WE CURRENTLY MANAGE STORMWATER?

In order to manage the amount (quantity) and cleanliness (quality) of stormwater runoff within the Village, we currently:


- Maintain storm sewer infrastructure
- Sweep streets and clear debris from drainage ways
- Provide leaf collection
- Inspect and enforce construction site erosion control standards
- Monitor detention basin maintenance
- Review and approve land development stormwater management practices
- Conduct engineering studies to determine infrastructure needs and reduce flooding risks
- Conduct water quality studies to determine pollution reduction needs
- Improve and expand storm sewer system as part of capital improvement projects

However, under the State's new WDNR rules, this is not enough.

WHAT IS THE VILLAGE REQUIRED TO DO?

The new State rules require that the Village of Whitefish Bay reduce pollutant loadings to Lake Michigan by 20% in 2013. Additionally, the Village is required to undertake a number of new activities, such as:

- Monitoring stream bank erosion
- Updating and enforcing stormwater and illegal dumping ordinances
- Educating the public on how to reduce stormwater pollution
- Obtaining WDNR discharge permits
- Reporting annually to the WDNR



To meet these State mandates and improve the existing stormwater infrastructure with quantity / flood mitigation projects, the Village will need to increase the funding of the current stormwater management program by millions of dollars over the next few years.

WHEN WILL THE UTILITY BE STARTED?

The Village adopted the stormwater utility ordinance in July of 2013. Utility billing will begin in December of 2013.

STORMWATER UTILITY AS A SOLUTION

A stormwater utility fee is a service fee based upon each parcel's equivalent runoff/residential unit (ERU). The ERU is based upon the impervious area of a single family residence, with an average residence equal to one ERU. As part of the utility creation, each residence was measured to determine the impervious area. This measurement was then converted to an ERU.

The Village's stormwater utility will have a rate of \$100 per ERU per year, broken down between a \$60 base charge and a \$40 equivalence charge. The \$40 equivalence portion may be decreased based upon credits, adjustments, and rebates, if applied for and approved by the Village. The Village will have each parcel's ERU on file for review and adjustment.

WHY DO WE CARE ABOUT STORMWATER?

A major source of pollution to our rivers, streams, and lakes nationwide, and here in Wisconsin, is stormwater runoff. Runoff from rain and snow melt flows over land and streets to our collection system's pipes, ditches, culverts, and detention facilities until it reaches our streams and Lake Michigan. This runoff carries with it trash, debris, motor oil, and automotive residue from our streets and parking lots, herbicides and pesticides from our lawns, and sediment from construction sites. If not controlled, these pollutants go straight into our water supply.





