

NEIGHBORHOOD *recipe* BAKING POWDER BISCUITS



Tip: If you don't have a cast iron skillet, you can bake on a cookie sheet for 11-13 minutes.

Ingredients

- | | | |
|-------------------|---------------|----------------------|
| 3 C flour | 1 ½ tsp. salt | 4 tsp. baking powder |
| ½ C vegetable oil | 1 C milk | |

Directions

1. Mix dry ingredients together in large bowl.
2. Make a well in the center of the flour mixture and pour in the oil, cutting in with a pastry blender. (Do not use a fork.)
3. Mix in milk until dough is slightly sticky.
4. Knead the dough on a floured countertop 4-5 minutes. Pat or roll to about ¾ in. thick.
5. Cut out biscuits and place in a large, seasoned, oiled cast iron skillet. Biscuits should touch each other.
6. Bake at 400 deg. for 17-20 minutes, or until golden brown.

Winter Tree Pruning

The Village's urban forest is pruned on a seven-year cycle with approximately one-seventh of the public (street) trees pruned annually to maintain good tree health and structure. During the winter months, the larger trees are pruned by a private contractor (those trees marked with a black dot) and the smaller trees are pruned by village crews. Common reasons for pruning are to remove dead branches, to remove crowded or crossing limbs that may create future structural problems, to eliminate hazards and to remove lower obstructing branches. Please see the map for the location of the 2013 Pruning Area.

2013 Elections

This year the Village is preparing for two scheduled elections. The Spring Primary will be held on February 19, 2013 (if a primary is needed), and the Spring Election will be held on April 2, 2013. Offices up for election include the Superintendent of Public Instruction, Supreme Court Justice, Court of Appeals and Circuit Court Judges, Whitefish Bay School Board, and Village Trustee. Polls are open from 7 am – 8 pm. To find your polling location please visit the Village website; www.wfbvillage.org.

How to Register To Vote

If you are new to the Village, recently moved within the Village, changed your name, or have never voted, you may need to register to vote. You may register to vote by mail, in the Clerk's office, or at your polling location on Election Day. If you have any questions about Elections or registering to vote please contact Deputy Clerk Kayla Chadwick at (414) 962-6690.

Absentee Voting

Are you going to be away during the 2013 Elections? You may apply to receive an absentee ballot by the mail or absentee vote in the Clerk's office the two weeks prior to the Election. The deadlines for absentee voting for the February and April elections are;

February 19th Election

- Deadline to request an absentee ballot by mail: Thursday, February 14 @ 5 pm
- Clerk's office voting: Monday, February 4 – Friday, February 15

April 2nd Election

- Deadline to request an absentee ballot by mail: Thursday, March 28 @ 5 pm
- Clerk's office voting: Monday, March 18 – Friday, March 29

Property Tax Installment Due

If you chose to pay your property taxes in installments, the 2nd installment is due by March 31, 2013. Village Hall is open Monday – Friday from 8:00 am to 4:30 pm. Tax payments are processed regularly with updates and printable receipts available on the Village website at www.wfbvillage.org. The Village has a lock box located in the entryway of Village Hall for the convenience of property owners wishing to pay their property tax bill during nonbusiness hours. Unless specifically requested, property tax receipts will not be sent to property owners, receipts may be printed at any time off the village website.

Police Department

Winter Overnight Parking Regulations

Village ordinance prohibits parking on Village streets between 3 am and 5 am without permission or permit. To request overnight parking permission, residents and their guests may call (414) 431-9060 or visit the Village website at www.wfbvillage.org.

Night parking is restricted to the portion of the street abutting property that is owned, rented, or otherwise occupied by the requestor. Permission will be granted for up to 15 nights per vehicle. Those exceeding the annual limit will be denied permission and referred to the Police Department during normal business hours to purchase a \$30 monthly overnight parking permit. Requests for overnight parking permission must be made prior to 3 am of the current day. Parking permits may be purchased at the Police Department between the hours of 8 am and 9 pm. Between Nov. 30 and April 1, monthly permits may be purchased only for the following areas:

- E. Chateau Pl. (north and south sides from N. Santa Monica Blvd. to N. Anita Ave.)

- N. Anita Ave. (west side from N. Chateau Pl. to N. Shoreland Ave.)
- N. Shoreland Ave. (west side from E. Chateau Pl. to N. Anita Ave.)
- N. Diversey Blvd. at E. Silver Spring Dr. (west side of N. Diversey Blvd. from E. Silver Spring Dr. south to alley)
- N. Diversey Blvd. at E. Henry Clay St. (west side of N. Diversey Blvd. from E. Henry Clay St. north to alley and the north side of E. Henry Clay St. from Diversey Blvd. to a point 40 feet to the west)
- N. Oakland Ave. at E. Glendale Ave. (east side of N. Oakland Ave. from south Village limits to a point north of E. Glendale Ave. and the south side of E. Glendale Ave. from N. Oakland Ave. east to the posted sign)
- Winkie's Municipal Parking Lot (east parking row at south end of parking lot)
- North Shore Fire Department Parking Lot (west parking row at south end of parking lot)

PLEASE NOTE: Night parking permits are not valid during snow emergencies.

Snow and Ice Winter Regulations

During the Winter Months, the Police Department would like to remind residents of the following regulations that are present in Village Ordinances pertaining to snow and ice removal:

Power Snow Removal Equipment

Usage Ord.8.02(5)(a) prohibits snow removal using snow blowers and vehicle mounted snow removal devices within 50 feet of any building used as a residence by another person between the hours of 10 pm and 6 am.

Ord. 8.02 (5)(b) Except as otherwise permitted by ordinance, snow plowing by means of vehicle driven snow removal equipment utilizing a back-up alarm is prohibited in the Village between 10 pm and 6 am.

Ord. 8.02(5)(c) Snow plowing by means of vehicle driven snow removal equipment legally without the use of a back-up alarm shall not be subject to any time restriction.

If the back-up alarm is disabled, plowing may occur regardless of the time of day as long as it is not within (50) feet of any building used for residential purposes.

Ice and Snow Covered Sidewalks

Ord. 7.08 (1) requires residents and/or property owners to clear sidewalks of snow and ice within the 24 hours after a snow/ice event. If the ice cannot be removed, the resident or property owner is required to use sand or other substances to provide traction until the ice can be removed. Please shovel any crosswalks if adjacent to your property through a corner or intersection. Failure to comply with this ordinance may result in citation in addition to the cost for removing and de-icing by the DPW. Please make arrangements for your sidewalks to be kept free of snow and ice if you will be out of town. An unplowed sidewalk or drive way can alert criminals to an unoccupied dwelling.



Depositing of Snow

Ord. 7.08(2) establishes provisions relating to the depositing of snow on property other than that of the owner. This prohibits the pushing, piling, blowing, or shoveling of snow into and across a public street or alley. Please remind all contractors that you use for snow removal of this requirement to ensure the ordinance is not violated. Snow windrows can cause damage and injury if left to obstruct roadways. It also creates significant cost over-runs when Village crews have to clear the roadways more than once.

Eye Care that Serves You and Your Community: Christina Petrou Haefs, O.D. Has Her Sights Set on an “All in One Place” Clinic

Dr. Christina Petrou Haefs, a primary care optometrist, low vision specialist and North Shore resident has been serving the North Shore communities for almost 22 years, working at medical or optical offices in Glendale, Fox Point, Whitefish Bay, and Milwaukee after graduating from the Illinois College of Optometry in 1990.

Last April, Dr. Petrou opened Petrou Eye Care on North Port Washington Road in Glendale, this area's first medical optometry and low vision clinic. Her goal was to create a unique clinic setting to provide specialized eye care services to help her patients see better.

“I think of eye health holistically. Because the eyes are an important part of the body, many conditions that affect the body have an impact on the eyes and vision system,” says Dr. Petrou. Her main focus is educating her patients on how to keep their eyes healthy throughout their lifetime. Patients benefit from the latest prescription lens technology, computer vision correction, to help them maximize their vision.

“Many people's eyes are strained because of prolonged desk work, especially if they aren't wearing the most appropriate correction for viewing a particular device and staring at it for hours a time. A thorough eye health exam and an accurate prescription can relieve tired eyes.”

Another unique service that Dr. Petrou provides is working with people who have had partial vision loss. Vision that cannot be restored with conventional glasses, contacts, or surgery is called low vision. As a resource for local ophthalmologists and other medical and vision specialists, Dr. Petrou developed a low vision clinic and team to offer rehabilitative services to visually impaired children and adults needing to function and see better.

Dr. Petrou currently resides with husband Brian and her two kittens Kato and Turi in Fox Point. When she moved there three years ago, Dr. Petrou immediately fell in love with the neighborhood. She and her husband thoroughly enjoy the natural beauty and wildlife that the North Shore has to offer. They regularly hike together in the parks and along the lakefront. In her spare time, Dr. Petrou also enjoys gardening at home, sailing with her husband, traveling with family, and spending time with friends.

Raised by Greek immigrant parents who stressed the importance of close family relationships, she values the sense of community and the family-like connectedness that the residents of her Fox Point subdivision share. “Despite our private lives, we are close neighbors and I think of them as family,” reflected Dr. Petrou.

Fox Point is a very outdoor-

oriented community. “Brian and I enjoy the passing-by of neighbors, dog-walkers, joggers, and bikers along our street. We've met many interesting and kind people here. And if you want to know what the weather is like that day, all you have to do is look out the window at what people are wearing.”

I'm Going On a Picnic

One family member starts the game with, "I'm going on a picnic and I'm going to bring apples." The next player takes a turn, adding their own item that begins with the next letter of the alphabet while remembering all the items brought previously. After a few turns, you might hear, "I'm going on a picnic and I'm going to bring apples, bananas, carrots, donuts and eggs." Variations: Change the theme from picnic to some other destination, or modify what you can bring. Don't feel limited to bring only food if you all agree you could bring other items, too.

Don't Say "Yes"

In this game, two people take turns asking questions to which the obvious answer is "yes," but the trick is that you can't respond with "yes." For example, person one could say, "Is your name Tom?" Person two would answer, "Actually, my name is Thomas." Then Thomas (a.k.a. Tom) asks the next question.

Back to Back

This word game requires players to think on their feet. The first player chooses a word, such as "giraffe." The second player then responds with a word that begins with the ending letter of the previous word spoken. Since "giraffe" ends in "e," the second player must choose a word that begins with "e," such as "eggplant." The game continues for as long as you want to play or until it takes a player too long to come up with a word that begins with the correct letter.
